ADOPTION OF RESOLUTION**

**SEMINOLE COUNTY
BOARD OF COUNTY COMMISSIONERS**

On March 24, 2009, the Board of County Commissioners of Seminole County adopted Resolution No. 2009-R-57(attached) with the following title:

RESOLUTION REGARDING ONSITE SEWAGE TREATMENT AND DISPOSAL SYSTEMS IN THE WEKIVA STUDY AREA, ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, MARCH 24, 2009

RESOLUTION REGARDING ONSITE SEWAGE TREATMENT AND DISPOSAL SYSTEMS IN THE WEKIVA STUDY AREA, ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, MARCH 24, 2009

WHEREAS, the Florida Department of Health is not required to adopt rulemaking for onsite sewage treatment and disposal systems within the Wekiva Study Area, unless appropriate; and

WHEREAS, the Florida Department of Health's Technical Review and Advisory Panel has tabled proposed rulemaking for onsite sewage treatment and disposal systems within the Wekiva Study Area; and

WHEREAS, enactment of rulemaking by the Florida Department of Health, as proposed, poses significant financial hardship for thousands of residents of Seminole County during fragile economic times; and

WHEREAS, implementation of rulemaking by the Florida Department of Health, as proposed, the proposed rule is untimely in view of the current widespread economic downturn and restricted lending climate; and


WHEREAS, the Florida Legislature has allocated funds for a study to address nitrogen reduction strategies that could have statewide implications.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, SEMINOLE COUNTY FLORIDA, THAT:


